

Introduction



he focus of this 2007 Annual Report is development since this is among the most critical areas facing Anatolia today, and the support and full participation of all Trustees will be absolutely necessary to mobilize the school's donor base as the current capital campaign enters the critical public phase over the next two years. It is hoped that Trustees have received a satisfactory flow of information on campus academic, extracurricular and outreach activities over the past year in the form of committee and periodic reports, ACT Vision, the Anatolia Newsletter and occasional updates from the President. We have, nevertheless, included here a selective listing of Anatolia and ACT events over the past 12 months to give at least a flavor of campus life.

The remainder of this report focuses on development objectives and performance, donations over the past year and a financial record of contributions and development costs.



natolia is one of Greece's most distinguished private, non-profit educational institutions. Founded in 1886 and incorporated in Massachusetts in 1894, Anatolia was originally located in Marsovan, Asia Minor. Following its closure in 1921, Anatolia was invited by Eleftherios Venizelos to relocate to Thessaloniki, which it did in early 1924. Since the early 1930's, the school has operated almost continuously on an extensive pine-covered campus in Pylea, a Thessaloniki suburb.

The Anatolia family of schools consists of its original secondary division, Anatolia College, which includes an English-language International Baccalaureate (IB) Program. The high school is complemented by Anatolia's university-level division, the U.S.accredited American College of Thessaloniki (founded 1981), which today offers B.A., B.S., and MBA degrees to nearly 500 students from Greece, Southeast Europe, and the U.S. Anatolia Elementary School (established 2004), the institution's newest educational division, which extends Anatolia's educational mission to grades K-6.

Today, nearly 2,500 students attend one of Anatolia's three divisions, and the institution takes great pride in its nearly 13,000 alumni in Greece, Europe, the U.S., and throughout the world who consistently distinguish themselves, generation after generation, in the professions, the arts and letters, scientific research, as well as business and entrepreneurial activities.

We invite you to join us in this brief overview of the year just passed, a year

- filled as ever with student accomplishments at all levels, both within and beyond the classroom
- featuring a full roster of speakers on subjects ranging from the global economy to the Parthenon frieze
- crowned by new collaborations with peer institutions at home and abroad, which will ensure that our students continue to receive cutting-edge international educations
- witnessing the full use of a new classroom facility, the completion of a major renovation of our campus performing arts center, and the final planning stages to renovate our indoor gymnasium

ANNUAL ANATOLIA CHRISTMAS CONCERT

This was the first time elementary and high school students collaborated on a project of this magnitude 250 students from the Greek Dance Club, Chorale, Pegasus, Musical Ensemble and Greek Oral Interpretation Club performed.

21, 26-28 ANATOLIA THESPIANS BRING SHAKESPEARE TO CAMPUS

Anatolia's acclaimed Drama Club delivered five sell-out performances of *The Complete Works of William Shakespeare Abridged,* in late January, and six weeks later (March 3-4, 9-11) the Greek Theater Club repeated their fellow-thespians' success with their interpretation of Aristophanes' *The Assembly Women.* The latter group continued a long-standing tradition of donating the proceeds from one performance to the St. Demetrios Children's Hospital adjacent to the campus.

ACT STUDY ABROAD STUDENTS ARRIVE IN RECORD NUMBERS

In summer 2006, ACT welcomed 60 American students the largest group ever in the history of the ACT's Study Abroad program. In late September, ACT welcomed 62 Study Abroad students (another record) for the fall term, while 84 students from 30 different universities across the U.S. arrived on the ACT campus for the spring term. That's three records in a single year!



DUKAKIS VISIT TO ANATOLIA HIGHLIGHT OF SPRING 2007

Former Massachusetts Governor and Honorary Trustee Michael S. Dukakis, accompanied by his wife Kitty, returned to Anatolia and to ACT to occupy ACT's Michael S. Dukakis Chair in Public Policy and Service, created in 1999 to commemorate his accomplishments in American public life.

On April 16, he inaugurated the newly renovated Raphael Hall in a symposium with Deputy Minister Stylianides (now Education Minister) and author Nick Gage. He also participated in a digital videoconference with students and faculty from ACT and Boston College, and found time to speak with Anatolia high school and IB students. In Athens, Dukakis made the case for private, nonprofit higher education to the Greek President, Education Minister and Opposition Leader.

30 ANATOLIA COLLEGE COMMENCEMENT

The Class of 2007 230 strong celebrated their graduation on June 30, where the featured speaker was Anatolia alumna Dr. Nina Papavasiliou ('88), Professor and Director of the Laboratory of Lymphocyte Biology at Rockefeller University, one of the world's top biomedical research centers.

Top academic awards this year went to: Demetrios Lagoudis (1st Lykeion), Konstantinos Bakas (2nd Lykeion), and Argyrios Tsiaras (International Baccalaurate).

And turning towards the future, Fall 2007 saw no fewer than 16 Anatolia IB graduates entering U.S. universities, including Amherst, Bates, Bard, Boston University, Georgetown, Mt. Holyoke, Smith, and Yale among others. The new year began on campus with record

elementary school enrollment of 399, all places filled in the High School, including a record 114 IB students, and ACT entering class enrollment up 24% for a total Fall 2007 undergraduate and graduate enrollment of 441.

In January 2005 Chairman Bissell and the Board launched a five-year capital campaign which will conclude in December 2009. We are pleased to report that, coming to the close of the "quiet" phase of the campaign, we are nearly halfway towards our goal of \$20 million. This is, however, due to generous legacies to the school, and there is much work remaining to be done. We will shortly be entering the "public" campaign phase in which you can expect to be approached to participate in this important endeavor if you have not already done so. We now have in place an active Director for European Development, Maria Tsekou '82, based in Athens, and expect soon to make a comparable appointment in Boston. Please, therefore, respond positively when they or Trustees of Anatolia contact you. Not only your direct contribution but also your possible referrals to individuals, corporations and foundations, that in your judgment could be convinced to support our cause, would be highly valued.

Those of you who have recently visited the campus have seen its spectacular new facilities such as the Ingle Hall Classroom Annex or the Raphael Hall Performing Arts Center. These buildings were deemed

so essential to carrying out Anatolia's educational mission that we built them before all funding was in place. There are thus still very attractive naming opportunities classrooms, theatrical spaces and more in both, and we seek as broad participation as possible from the Anatolia family in order to complete these projects. The indoor gymnasium, state-of-the-art in 1975 but now sadly behind the times, as well as our outdoor athletic facilities, are additional areas awaiting your help. Scholarships, always important at every level of Anatolia, are a further continuing need of the school.

We owe it to today's students in all divisions of Anatolia to receive an education that is second to none. In preparing for an the uncertain world beyond the idyllic Anatolia campus, they will need all the humane judgment, analytic skills and technological mastery that we can instill in them.

The Capital Campaign:

A Snapshot as of November 2007

s Jack Clymer and Antonis Kamaras note in their message above, the current capital campaign was announced in 2004 by Chairman Bissell for five years from January 2005 through CY2009 with an initial goal of \$20 million. As reported at the May Trustee meeting in Thessaloniki, progress during the initial quiet phase has been respectable owing to several significant legacies to Anatolia. These, however, have been, for the most part, tied to specific donor wishes, largely in the scholarship area, and do not, therefore, relate directly to priority campaign needs, identified by the school administration and Facilities Committee and outlined in the following pages. As a result, it was agreed at the May meeting that the quiet phase of the campaign should be extended through CY2007 to permit broad participation by Trustees and major donors. A key priority was identified as well-organized and prepared calls on all Trustees and designated major donors over the remaining months.

As a goal, the US and Greek sides were challenged to reach by the end of 2009 a 50% achievement rate by each side in grants and pledges toward the \$20 million campaign goal.

On the Greek side, the past year has seen gradually increasing traction as the new Director for European Development has established herself in Athens and developed close working relations at all levels of the campus through regular visits. The Greek campaign received a boost through an upscale dinner hosted by outgoing American Ambassador Charles Ries, April 27, to bolster Anatolia development efforts on the occasion of a visit by Michael and Kitty Dukakis. The event brought together some 140 Athenians including major business figures outside the normal Anatolia orbit. These constitute a new universe of potential donors and the Development Office and President are working to consolidate these initial ties. While efforts are underway to broaden alumni giving and to establish the tradition of reunion gifts, generally absent in Greece, a particular focus has remained cultivation of major potential donors, and a number of these cultivations are active and ongoing. To date, progress in the scholarship area has been particularly noteworthy and this appears to be the most attractive current area for Greek donors, particularly alumni and corporations. While the scholarship endowment is down, owing to the dollar depreciation and the fact that major new Weter and Raphael legacies have not yet come on line, Greek corporate and individual donors, as well as several US Trustees, have come forward to ensure that all high-potential students with clear economic need received the assistance necessary to enroll in September 2007.

On the US side, efforts by the Chairman and the Development Committee Chair to recruit a dynamic new development director for the Boston office have intensified and, we hope, will lead to strong new leadership there as the capital campaign enters the two-year public phase.



2007-2008: The Year to Come

ince its reestablishment in Thessaloniki in the early twentieth century, Anatolia's stellar reputation has been built on a three-pronged approach to education that includes outstanding academics, American-style extracurricular clubs among which the performing arts clubs have long held pride of place and athletics. This balanced approach to educating the whole individual, time tested and well honed in America, constitutes Anatolia's strongest claim to being nearly unique among secondary educational institutions in Greece.

Clearly, the two most important ingredients for long-term, continuing success as an educational institution are an outstanding faculty and student body, the latter supported by scholarship endowments and yearly giving to ensure that an Anatolia education is available to all those young scholars most able to take advantage of its benefits.

The third ingredient teaching and support facilities where both the academic and extracurricular portions of the program can be carried out at the level of excellence traditionally associated with Anatolia is the focus of the current phase of the Anatolia development campaign, scheduled to emerge from its silent phase in 2008.

Our campus, acquired in the late 1920s and gradually built up over the course of the next half-century, was the subject of lively discussion as we entered the 21st century, when the Anatolia Trustees and campus arrived at a comprehensive medium-range plan to greatly renew and upgrade existing teaching, performing arts, and athletic facilities on the grounds of the original campus. The campus facilities development plan arrived at is being systematically implemented in stages, and we are very proud to announce that to date we have completed:

- A substantial addition on our South Campus, the **Ingle Hall Annex**, which has added 10 teaching rooms, a series of science labs and art room, and an indoor exercise room for the use of our secondary school students
- A major renovation of an existing building on our Main Campus,
 Raphael Hall, which is providing for the first time in Anatolia history a modern performing arts center for

our many student and alumni performing arts groups both dramatic and musical as well as a venue for guest artists and public lectures and conferences.

For the upcoming year, we have scheduled

• A complete overhaul of our **indoor gymnasium**, also on the Main Campus, which will vastly improve electrical-mechanical installations throughout the facility, add new spaces for a number of sports, and bring the structure's exterior into aesthetic harmony with the historic stone structures on the original quad.

As the latest Development Campaign nears completion of its silent phase, Anatolia is reaching out to donors among alumni, friends, and organizations, offering a wide range of donor options for each of these campus capital projects. We warmly invite our Alumni, Friends, and other Supporters to visit the campus or contact our Development Offices in Greece and in the US to learn more about these opportunities.

While all of the above have been accomplished and the Performing Arts Center is already functional, completion of the final phase of this vital project is in abeyance until funding is secured.

The Raphael Hall renovation has resulted in a major upgrading of Anatolia's theatrical and musical performing facilities, offering students the opportunity to experiment with a variety of performance formats and providing a new campus venue for artistic guest performances and conferences.



2007-2008: The Year to Come


uring the 2007-2008 academic year, we will be carrying out a comparable renovation of our aging indoor gymnasium.

The gym renovation's main goals include:

- Realignment of entranceways through a new windbreak entrance
- Upgrading of the main court with new flooring, acoustic and lighting systems
- Reconstruction of all locker rooms and player bathrooms/showers
- New visitors' facilities
- New squash court annex
- Enhanced fire safety through provision of new emergency exits
- New drainage and natural gas systems
- Heating and electrical installation upgrades
- Energy conservation gains through replacement of all embrasures







Scholarship Summary

ince its earliest years, Anatolia has maintained a tradition of providing scholarships to substantial numbers of its students. These scholarships are awarded on the basis of a combination of merit and financial need. Study at Anatolia College and ACT by these outstanding students is fully supported through annual gifts and return of scholarship endowments.

For Anatolia High School, half of scholarship holders come from Thessaloniki and about half from the provinces. The latter students live and board in Anatolia's dormitory receiving full support to do so. For the ACT/MBA and undergraduate program, scholarship students come from Greece and other countries, particularly from the Balkan area.

Over the past years, while the number of scholarships funded from the endowment has decreased, due to the exchange rate between the euro and US dollar, this has been compensated by the increasing number of new donors among Trustees, corporations, associations and individuals. Support for scholarships by alumni, friends, corporations and foundations is critical to the institution's mission, particularly in light of rising tuition and fees over the past few years, which has made an Anatolia education unattainable for many bright and ambitious students.

Several of our Trustees continue supporting our scholarship programs with new donations, in many cases in addition to other ongoing scholarship students whom they support, such as

- Leonidas Evangelidis (one fulltuition, six year HS scholarship)
- Elias Kulukundis (two full-tuition, four-year ACT scholarships
- Kitty Kyriacopoulou (two full-tuition, two-year ACT scholarships)
- Helen Lindsay (two full-tuition, fouryear ACT scholarships)

Furthermore, because of our Trustees and Alumni efforts and networking, the Jewish Community of Thessaloniki has been approached resulting in pledges of three full-tuition scholarships for Jewish students from the Balkan countries to attend ACT.

ew contacts with top corporations have been established and produced positive results for the support of our scholarship programs. Some of these are:



In addition, several grant proposals have been submitted to different Foundations - Latsis, Bodossakis and Papageorgiou to fund scholarships for academically talented students with demonstrated financial need.

AY 2007/ 08 is a successful year with focus on Scholarship programs. Currently 85 students from High School receive scholarship support, 24 at IB program, 27 for ACT undergraduate studies and 15 for the MBA program. (See chart on right).









Financials

verall, Anatolia had another successful year in 2007 in terms of its financial profile and progress. The generous contributions from donors in Greece and the US along with the positive climate in the world capital markets allowed the school to experience a highly productive year.

The Audited Condensed Consolidated Statement of Financial Position presents total assets as of June 30, 2007 of \$63.8 million, a \$9.5 million increase from that of the prior year. Total net assets also increased by \$8.6 million during the same period to \$56.0 million at June 30, 2007. The Condensed Consolidated Statement of Activities indicate a financially strong year with a surplus of revenues over expenses of \$7.5 million, almost double the surplus of \$4.1 million in 2006.

Anatolia operations, located in Thessaloniki, Greece, include a 1,300-person high school with an IB program (Anatolia College), a 450-person four-year U.S. accredited college (American College of Thessaloniki), and a Greek Corporation holding a pre-kindergarten, kindergarten, and elementary complex

comprising approximately 400 children. Significant enrollment increases were recorded at the Elementary school and the International Baccalaureate program. Enrollment at Anatolia College reached full capacity consistent with previous years, while the American College of Thessaloniki accepted a freshman class 26% larger than the prior year. Noteworthy is the increased interest in the study abroad program at ACT which in 2007 enrolled in excess of 200 US students. These enrollment increases benefited tuition revenues, a large component of Anatolia's operating revenues.

The College's goals are to offer the best of Greek and American education, to provide a strong program in English language and literature, and to encourage extracurricular activities both intellectual and athletic. The relatively small increase (4%) in 2007 operating costs is justifiable in terms of the Greek economy considering Anatolia's ambitious mission and determination to excel in a highly competitive market. Maintaining prudent fiscal management and a tight control on operating costs is a high priority for Anatolia.

Development efforts in 2007 were marked by the establishment of a fund raising team in Greece for the first time. The result has been an increase in Greek donations while in the US revenues from new gifts and pledges totaled \$3.4 million. Anatolia's endowment exceeded \$36 million in June 2007, the result of substantial new gifts and continued performance above benchmarks. Restricted endowment revenues, calculated on a previous 12 quarter average, provide the core funds for Anatolia's financial aid program. A higher spending rate was approved for 2007 to make up for part of the loss sustained from the unfavorable US Dollar to Euro ratio with income created in US Dollars and spent in Euros. Approximately 58% of the \$1.3 million allocated to be spent for financial aid in 2007 came from endowed funds, 34% from annual gifts and 8% from operational funds. Financial aid funds were further distributed 22% to ACT and 78% to Anatolia College.





A major upgrade of campus facilities started in 2005 with construction of the Annex to Ingle Hall to be used as a classroom building, a new soccer stadium and renovation of the Kindergarten building. The upgrade continued in 2007 with conversion of the Raphael Hall to a contemporary Performing Arts Center and an extensive renovation of the main campus tennis courts. These two projects, in total exceeding \$1.7 million, were completed with assistance from a USAID/ASHA grant and an internal loan to be paid back with funds raised from private donations.

Projected further expansion of the Elementary School, the enhanced interest in the International Baccalaureate program and increasing enrollment at the American College of Thessaloniki create expectations of higher tuition revenues for 2008.

While a major challenge remains to create additional revenues through new activities, efforts will continue towards further containment of the operational costs.





Notes to Condensed Consolidated Financial Statements (dollars in thousands):

- (1) The condensed consolidated financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- (2) The College's accounting records in Greece are maintained in Euros. The foreign currency equivalents are translated into U.S. dollars.
- (3) The College is a tax-exempt organization exempted from income taxes in both the United States of America and in Greece.
- (4) Investments at fair value as of June 30, 2007 consisted of short term investments (\$6,748), equities (\$22,948), fixed income (\$5,877) and other (\$463) for a total of \$36,036.
- (5) Fixed assets, consisted principally of buildings and equipment, are stated at cost and presented net of accumulated depreciation of \$10,519 and \$8,688 in 2007 and 2006, respectively.
- 7) The College has several defined contribution annuity retirement plans covering the majority of its full-time faculty and administrative personnel. The amounts charged to expense for these plans were \$608 and \$728 for the years ended June 30, 2007 and 2006, respectively. A termination fund for Greek employees is also payable upon their retirement or involuntary termination, as provided by Greek law with the amounts charged for this plan \$196 and \$120 for the years ended June 30, 2007 and 2006, respectively. The accounts payable and accrued expenses presented on the balance sheet include \$1,884 and \$1,643 respectively for each period, relating to this long term obligation.
